30-60%

Apply lower risk weights to trade finance assets, **unlocking** 30–60% of tied-up capital, which equates €100 million to €1 billion capital savings for mid-size and large global banks.

90%

Reduce up to 90% in expected credit loss reserves, improve provisioning accuracy and boost balance sheet flexibility.




